Mr. C.T.John reported that he would not get time to attend the activities of the Club for some time since he has to look after the affairs of his late brother at Trivandrum. Hence the Joint Secretary Mr. M.M. Mathew was authorised by the Committee to conduct the regular rifle practice of the Club.

To make up the deficit and also to make some funds for the Club it was decided to arrange a Kerala Performance at Mount Carmel Hall. Mr. P.C.Churian was unanimously elected Convenor to arrange this programme and he consented to do it.

The Collection of arrears of subscription from members was entrusted to the Committee members present and the Secretary as requested to give the list to the Committee members.
