OF THE EXECUTIVE COMMITTEE MEETING HELD ON 4.3.1986

An Executive Committee Meeting of the KOTTAYAM RIFLE ASSOCIATION was held at 4 P.M. at the District Collector's Office on the 4th of March 1986.

The meeting was presided over by Shri.K.J.Mathew, I.A.S., the President of the Club.

The Secretary Mr.C.A.George read the minutes of the last Executive Committee Meeting held on 14th Oct. 1985 and the same were passed.

It was pointed out by Mr.Sunny Thomas that the Club having sent two notices to all members giving all in arrears a period of one month to pay up their dues or loose their membership was wrong and that a fresh notice should be sent, as per the decision of the previous Executive Committee Meeting.

To this it was pointed out by Mr.Pothan Joseph that this was in principle wrong even if it has been done by the previous Secretary and Committee. It was further pointed out that if this were the case, then no decision taken by the Executive Committee would be valid as these could be revoked or questioned in a court of law; quoting this as precedence. It was finally decided to send Registered Notices to all in arrears giving them upto 15th April 86 to pay a consolidated sum of Rs.60 by cheque or D.D. by Registered Post; crossed in favour of the Kottayam Rifle Association. This would be final and no excuse whatsoever would be accepted for further extension.

Application received after 12.11.85 would be kept in abeyance and would be given first priority for membership as decided by the Committee.

The Secretary produced six letters giving notice of dues and termination for non-payment, addressed to various members which were wilfully returned with the postal remarks- "Refused to accept". The Secretary has explained to the President that a certain number of members have wilfully done this and later claimed that they had not received any notice whatsoever.
