Minutes of the last meeting held on 11.12.94 was read and passed.

The Secretary reported that the tenders for the construction work of the extension of the Club Building and the boundary wall on the western side were after the approval of the sub committee was given to contractor Sri Biji Zacharia Coral builders. He has finished the work and after that the measurements were taken by Sri Saji Lal and calculations were made, and after his check-up and alterations, full payments were made.

Next item of the agenda was regarding the delay in the renewal and getting back of the gun licences of the Rifle Club Club Members from the office.

He said that membership of the Rifle Association is obtained only after police verification and also since Rifle Association is a Govt sponsored organisation, preference may be given to Club members in getting their gun licence renewed with out delay. Such preferences are essential for encouraging the activities of the Rifle Association.

S.P Sri K N Bal I.P.S promised to arrange speed verification and delivery of the gun licences of the members of the Rifle Association. To identify the applications of the Club members, a seal of the Association shall be affixed on the application.

Treasurer Prof Sunny Thomas presented the accounts. Accordingly Rs 69077/- was the expenditure for the building extension, Rs 79107/- was paid for the side wall (total 81607 for the side wall and other additional work). Another Rs 35304/- was spend for the trench, side door, Rain channel, target frames and ladder etc.,.

This was approved by the committee.

Secretary reported ~~xxx~~ that some more levelling of the ground and other finishing touches are necessary.

He also reported that ~~x~~ after the last committee meeting, we had conducted Dist Competition in shooting for both seniors and juniors on 23rd April 95. The winners were Seniors- Sri Mohan Jacob First and Joseph Joseph Second - Juniors - Master Sachin Motty Alex - First; and Kumari Sona Suzanne Thomas second.

The meeting then congratulated Prof Sunny Thomas on his re-appointment as national coach. Prof Sunny Thomas then gave a brief account of his experiences as National Coach.
