







Urgent Executive Committee meeting held or

8 members were present.


After a silent prayer Secretary Sri P K Mohan read the minutes of the previous Executive Committee meeting held on 13th March and it was unanimously passed.

11 members were present.

Dist. Collector Smt. Mini Antony IAS presided over the meeting.

After a silent prayer Secretary read the minutes of the previous executive committee meeting held on 10<sup>th</sup> March 2010 and the same unanimously passed.

President asked the Secretary to explain the actions taken in the last meeting.

Secretary informed the following:

1. Two numbers .177 Rifles were imported through Capapie Sports, Mumbai which cost about Rs.1,50,000/-
2. Repair and paint work done on Range building, and re-named as "CT. John memorial Range". Inauguration of the same was done by the Hon. MLA Sri. V.N. Vasavan.
3. Shooting competition also was opened by Sri. V.N. Vasavan in the absence of the Supdt. Of Police Sri. P.G. Asok Kumar, by shooting with our .22 Pistol.
4. A sum of Rs.60000/- was expended for Range repair and two days competition held on 24<sup>th</sup> & 25<sup>th</sup> April 2010
5. An advance amount of Rs.94501/- was remitted to NRAI for the purchase of cartridges.
5. 2000 Nos. Stickers printed @ Rs.8/50 per sticker (Total cost Rs.17069/-)
6. Target printing done for Rs.6440/-

The meeting approved the expenses and ratified.

Secretary suggested that considering the valuable services of Mr. Panicker since 25 years, some financial assistance may be given to him for his hospital expenses. Prof. Sunny Thomas suggested all executive committee members may ~~be~~ give some financial help and all are agreed with it.

Secretary suggested to elect a selection committee for sending candidates to State Meet.





Executive committee meeting of the Kottayam Rifle Association was held on 24<sup>th</sup> September 2010 at 4.30 PM at Public Library Auditorium.

Nine (9) members were present.

As our president District Collector, Mrs. Mini Antony IAS was engaged with another meeting in connection with Panchayat Election, the committee nominated Mr. Abraham Ittycheria to preside over the meeting.

The meeting started with a silent prayer. Another silent prayer and condolence messages were passed in respect of our patron member "Padmabhooshan .K.M.Mathew of Malayala Manorama and P.C.Abraham Padinjarekkara, .who were the inspiring force of our Association.

Secretary read the minutes of the previous committee meeting held on 7<sup>th</sup> May 2010 and the same passed unanimously.

Income & Expenditure accounts for the year ended 31<sup>st</sup> March 2010 with the clarifications on following five items were read and explained by the Secretary and the same passed.

1. Expenses occurred for the Dist. Shooting Championship competition for Rs.10555/- .
2. A sum of Rs.600/- towards cost of a hockey stick was paid to Mr. Aniyam's daughter to participate in the hockey Championship.
3. Newspaper advertisement for a sum of Rs.8358/- in respect of our former Secretary - late C.T.John..
4. Repairing and replacing damaged roof of our Range building for a sum of Rs.30699/- under the supervision of our committee member Mr.Alex Chacko.
5. .An additional amount of Rs.27000/- was sent to NRAI for purchase of cartridges.

Secretary informed that the date of annual General body meeting can be fixed only after the discussion with our President – Dist.Collector- after the completion of Panchayath election process.

Mr.Cherian K.Kalarickal suggested that our treasurer – Dronacharya Prof.Sunny Thomas- may be given honorary Patron Membership on free of cost. He added that Sri.Maman Mathew , Chief Editor of Malayala Manorama also may be given the same post in place of his father late K.M.Mathew after getting confirmation.

Present fee for Patron membership and life membership may be revised to Rs.50,000/- and Rs.25,000/- respectively. Application for new membership may be recommended by member/executive committee member along with a copy of the applicants ID card.

Two numbers notice boards may be provided and erected in front of our office and inside of Range building.

Secretary informed that the present difficulty in getting cartridges from NRAI and suggested to restrict issue to our licensed members till supply position improves. .

Further suggested to elect a sub committee to check the sales and stock position.of arms and ammunition quarterly. One person may be trained to score marking and to participate in the competitions.. These two matters will be discussed in detail in the next annual general body meeting.

It is essential to keep our rifles from transit damages, a few gun carry bags to be purchased or manufactured locally. Reminded Mr.Cherian K. to speed up the matter and arrange to procure the same without further delay.

Mr.Cherian K. and Mr.Alex Chacko proposed to buy a few more open sight 0.177 Rifles. The Committee authorized Mr.Cherian K. to collect lowest quotations from various dealers/manufactures.

Secretary suggested to increase more candidates in competitions, it is essential to elect a sub committee to canvass selected Schools/Colleges/NCC and bring them under their own clubs and affiliate to our association.

Secretary also briefed certain points asked by Mr.K.S.Anto DYSP ; Narcotic Cell,Ktm.; in connection with the discussions had at his office on 22<sup>nd</sup> Sept.2010 as per the direction of ADGP Mr.Vincent M Paul IPS, Police head quarters, TVM. regarding any information of mal practice doing by Thodupuzha or other associations. It is decided to write a letter to our State President in this regard.

As there were no other points, the meeting terminated at 5.30 PM.
