Annual General Body Meeting of the Kottayam Rifle Assn was held on 6th Aug 06 at Nattakom Rifle Range at 5 PM.

As President Dist Collector was on another urgent duty he authorised A D M to preside over the meeting.

Accordingly A D M Sri Sajan Mathew presided over the meeting. 33 members were present.

After a silent prayer Secretary Sri C T John read the minutes of the previous General Body meeting held on 6th Jul 05 and it was unanimously passed.

Treasurer Prof Sunny Thomas read the Annual report and audited balance sheet for the year ended 31-3-06 which was already sent to all members in time. Then the President asked if there was any question to ask regarding the accounts and any matter connected with the working etc. No-body had any question to ask. Accordingly the Income & Expenditure accounts and balance sheet were unanimously passed.

Proposed by Sri Mohan Jacob and seconded by Sri George Chandy M/S Cheriyan & Cheriyan were re-appointed as auditor for the current year.

Prof Sunny Thomas said that the Kerala State Shooting Championship Competition will be held at Thodupuzha from 18th to 20th Aug 06 and maximum eligible shooters have to attend/compete in the competition. He also said that All Kerala School Shooting Championship Competition will also held at Muttom Range from 18th to 20th Aug and students representing their respective Schools could participate.

He also said that "Shooters Information Card" is necessary for the members who are attending the National Shooting Championship and G V Mavlankar Shooting Championship. Application for the Shooters Information Card is at our office. The members who require the same could come to the office and fill up the application form pay Rs 50/- and we could send it to the National Rifle Assn.

Secretary Sri C T John said that many members who recently joined did not turn up to the Club for practice. He also said that as already decided, cartridges will be issued only to the members who have weapons of their own after endorsing in their licence, and only at the shooting range on practice days. For practice in the range cartridges will be issued to all members on payment.

Mr Cheriyan K requested that the cartridges may be issued at concessional rate for the National Shooting Championship competition.

The result of the Dist Shooting Championship Competition was read by Sri M K Das.

As there was no other points for discussion, the meeting terminated at 5.30 PM.
