Minutes of the Annual General Body Meeting of the Kottayam Rifle Association held on 11th Jul 99 at Nattakom Range at 5 PM.

Sri BISHWANATH SINHA IAS (Dist Collector) presided over the meeting.

31 members were present.

Minutes of the last Annual General Body meeting held on 27th Sep 98 was read and passed unanimously.

Treasurer Prof Sunny Thomas said that the printed audited balance sheet and audited accounts for the year ending 31.3.99 was already sent to all the members along with the notice convening the meeting.

As suggested by many members it is taken as read and nobody has any question to ask and it was unanimously passed.

Proposed by Mr Babu Thomas and seconded by Sri Domenic Mathew M/S Cherian & Cherian is re-appointed as auditors for the current year on the same remuneration.

Mr Domenic Mathew said that since the life membership fee is ten thousand Rupees, the ordinary membership may also be raised. The present membership fee of Rs 1000/- may be raised as Rs 2000/- for those who join from July onwards. Regarding the yearly subscription the present rate of Rs 250/- per year may be raised to Rs 350/- per year to all the ordinary members, and for Junior members Assn Fee Rs 300 and Sub Rs 100/-.

This was approved by the members.

Secretary said that both A.D.M and A.C AR Camp are dealing with the rifles and cartridges and hence both of them may be included as HONDRARY committee members of the Rifle Assn.

This was agreed by the committee.

Meeting approved the conducting State Meet at our range by us and the committee mentioned for conducting the same was also approved.
