The Annual General Body meeting of the Kottayan Rifle Association was held at 5.30 PM on 13.6.92 in Collectorate Conferenc Hall.

35 members were present.

President Sri Sajan Peter I.A.S (District Collector) presided over the meeting.

After the silent prayer, Secretary Mr C T John read the minutes of the previous general body meeting held on 2nd September 1991.

Proposed by Mr George Varghese and seconded by Mr T J Oommen it was passed.

The next item in the agenda was " to consider the audited income and expense account and the balance sheet" for the year ending 31st March 92 and the report there on. As the printed income and expense account and balance sheet and the Annual Report were already sent to all members - the annual report was taken as read.
