Annual General Body Meeting of the Kottayam Rifle Assn was held on 20th Jul 2001 at 4 PM at Collectorate Conference Hall.

33 members were present.

President Sri Ajit Kumar IAS presided over the meeting.

After a silent prayer at the demise of our member Sri M E John, (Kottayam Sunny) Prof Sunny Thomas explained the valuable services rendered by him for our Club. He was always useful to all of our members at every time specially during the conduct of Dist Championship as well as State Championship competitions. He said that one main wing of our Club is lost, which is irreparable. President directed to inform his family our condolence.

Secretary Sri U T John read the minutes of the previous Annual General meeting.

Proposed by Sri A Jacob and seconded by Sri U G John it was unanimously passed.

Secretary said that the Annual report and the income/expenditure accounts and balance sheet were sent to all members in time, the President suggested that it may be taken as read, as the accounts and reports were circulated earlier. All the members agreed with the President's suggestion of taking the accounts and reports as read. Then President asked if there is any question to be asked regarding the accounts and reports etc. No-body had any question to ask. Accordingly the Income & Expenditure accounts and the balance sheet and reports were passed unanimously.

Sri Abraham Ittycheria in his speech welcomed our new President Sri Ajit Kumar IAS and requested his co-operation in our Club activities. He also welcomed Prof Sunny Thomas in his election as Vice President of the National Rifle Assn which is a great credit to our Club.

Dist Collector spoke his appreciation for the good performances of our Club. He assured all help and co-operation. He also said that the privileges which we are getting from National Rifle Assn such as getting of .22 BRND Rifles and Peep Sight Rifle and .22 foreign cartridges etc, is only due to the good approach of Prof Sunny Thomas at National level and as National Coach, Secretary of Kerala State Rifle Assn and Vice-President of N R A I.

Prof Sunny Thomas said that 2 nos of .22 BRND Rifles and one Peep Sight .177 Air Rifle have been allotted to Kottayam Rifle Assn from National Rifle Assn, and the same is ready for collection on production of licence from licencing Authy.

The Secretary said that the shooting practice will commence wef Aug 2001. All the members informed the President the difficulties they are facing for the renewal of their gun licence. President assured to take necessary steps to minimise the delay in getting the licences renewed.
