Minutes of the Annual General Body meeting of the Kottayam Rifle Association held on 20th <sup>December</sup> October 97 at 4.30 PM at Collector's Chamber.

26 members were present.

President Sri Satyajith Rajan IAS (Dist Collector) presided over the meeting.

Secretary readout the minutes of the last Annual General Body meeting held on 5th October 96.

Proposed by Sri P C Cherian and seconded by Sri T J Dhanan it was unanimously passed.

Treasurer Prof Sunny Thomas presented the Income and Expense account and the balance sheet for the year ended 31st Mar 97.

Proposed by Sri P K Mohan and seconded by Sri P C Cherian it was unanimously passed.

Prof Sunny Thomas (Treasurer) suggested that a sum of Rs 5500/- was given as loan to Kerala State Rifle Association (for medals for State Championship at Palakkad) and the same will be refunded when the contribution from other clubs received. Telephone expenses incurred by the Secretary of Kottayam Rifle Association (Rs 850/-) on account of statement of Palakkad may be given as advance from Kottayam Rifle Association and the same will be refunded by Kerala State Rifle Association when the fund available with them. The meeting agreed the proposal of Prof Sunny Thomas and the refundable loan ratified.

Secretary said that being a big Club of much dealings and much contact, he had to telephone to many places such as Irivanthur, Palakkad and other Clubs and even to our <sup>outside</sup> members occasionally and he find it difficult to ~~xxxxxxx~~ note-down regularly the correct place, person time and date etc, he could only present an all round figures bi-monthly when the tele bill of office and residence received. It is requested that all such bills, past and future after the approval of by the Treasurer may be ratified. The meeting after discussion approved his suggestion and request regarding the accounting of the telephone bills.

Secretary also said that as we are not getting .22 cartridges from A R Camp for the practice of our members, we have to get increased our yearly quota, so that we have to purchase more .22 cartridges from Amn Factory for the practice of our members. Meeting authorised the Secretary to do the needful.
