Treasurer Prof Sunny Thomas read the Annual Report and audited balance sheet for the year ended 31-3-04 which was already been sent to all members in time. 
Secretary said that this year " State Shooting Championship Competition" is to be conducted by us. Nearly about 50,000.00 is to be collected for the expenditure of the competition. Regarding the raising of funds, after a discussion it was decided that the amount is to be collected from our members. A committee consisting of Secretary Sri C T John, Domenic Mathew and Prof Sunny Thomas <sup>were</sup> ~~were~~ authorised to approach the members. The date of the competition is from 8th Jul to 11th Jul 04.

Secretary also said that a sum of Rs 10744.00 ~~was~~ was due from Mr V P George against cartridges value, which was issued to him for the National Competition. Out of the above amount a sum of Rs 7944.00 ~~w~~ has been paid by him and the balance amount Rs 2800.00 which is due from him ~~has~~ <sup>has</sup> to be ratified as the cartridges was issued to him for the National meet at the actual cost. The meeting ~~agreed~~ <sup>agreed</sup> to ratify the amount, as the same has been issued for the National meet.

Some of the members requested that they may ~~be~~ allowed to handle/pratice on the .22 Peep Sight Rifle. Prof Sunny Thomas explained that the .22 Peep Sight Rifle which is very costly is not allowed for practice to all members of the Club. Only those who are selected to participate in the National Competition are allowed to handle the same.
