An Extra Ordinary General Body Meeting of the Kottayam Rifle Association held on 27th Jan 02 at Nattakem Range at 5 PM. 27 members were present.

In the absence of the President and Vice-President, our senior committee member Sri T J Dammen presided over the meeting.

Secretary read the letter of the Income Tax Commissioner dated 24th October 2001 for Registration under section 12A.

After discussion " Resolved that the following rules be added as clause (g) and (h) to rule 13 of the Rules and Regulations:-

(g) " No amendments of the memorandum, Rules and Regulations will be made without prior approval of the Commissioner of Income Tax".

(h) Dissolution- " In the event of dissolution the net asset if any after satisfying all the debt and liabilities shall either be transferred to societies/Trust having the same or similar objects or shall be vested with the Government".

Proposed by Sri George VP and seconded by Sri George Chandy it was unanimously passed.

Secretary was authorised to get it registered with the Registrar of Societies and proceed with the matter with the Income Tax Commissioner for registration under section 12A.
